Chairman's Message

It is with great pleasure that I present the 2019 Annual Report on behalf of the Stock Feed Manufacturers' Council of Australia (SFMCA). 2018-19 proved to be as eventful as any year for SFMCA, with some significant changes having kept the organisation on its toes.

The 2019 season has seen the continuation and spread of a long lasting drought on the east-coast of Australia while the west-coast went from strength to strength. SFMCA is, of course, sympathetic towards those who experienced the difficult seasons.

The overall strong prices for poultry and red meat has enabled the continued feeding of stock for breeding and finishing purposes. Pork has, unfortunately, been riding the roller coaster with some signs of production starting to break even as we moved into the new financial year.

Internationally and nationally SFMCA has continued to build on the foundations laid down by John Spragg with his work with the International Feed Industry Federation and on national programs like FeedSafe, training program, TSE Freedom Assurance Program and the National Feed Standards. In addition, we have started working more closely with our enduser representative bodies such as Australian Pork Limited, Insect Protein Association of Australia, and key stakeholders Animal Health Australia, and Australian & State Governments. I continue to represent Australia on the IFIF Board of Executive Directors and Duncan Rowland at the International Feed Regulators Meeting. The Federal Council see these as pivotal roles for Australia as the effect of global legislative burdens start to play a part in trade negotiations.

Federal Government and national issues continue to influence our members, and the importance of our role and the contribution made by our staff and national delegates cannot be overstated. Each of these national issues has a direct effect on our Members' wellbeing and financial performance. In order to raise our profile on the national stage we have started holding meetings with the State Ministers for Agriculture and their senior staff. In March we met with the Tasmanian Minister for Agriculture and Energy, The Honourable Guy Barnett and staff. This was a low key dinner where matters of common interest were discussed. It is events like this that start to raise awareness of our industry issues with the governments.

September 2018 saw the end of John Spragg's 14-year term as our EO. John was an integral part of driving a number of cornerstone projects and his technical knowledge is second to none. We welcomed Duncan Rowland as our new EO in September 2018 and I am sure for those that have met Duncan and been a part of the work he and his team is undertaking on our (Members) behalf can say we are in good hands.

I would like to thank the SFMCA staff, all of whom have worked tirelessly and willingly carried extra responsibilities during the year. I also thank the elected representatives, whose voluntary contribution cannot be understated. Submissions, Memberships & Collaboration

Submissions

SFMCA continues to represent your industry on various issues, the following are some of the areas of representation through the year:

- Submission to the Queensland Government on the review of Queensland veterinary prescription regulation.
- WA Dept of Primary Industry and Regional Development (DPIRD) review of feed legislation.
- DPIRD review of agricultural chemical record keeping.
- Attendance at the National Biosecurity Roundtable.
- Submission to the Senate enquiry into National Horse Traceability.
- Sent letters to Animal Health Australia and Animal Health Committee requesting direction on regulatory controls for insect meal use in animal feeding.
- National Feed Standards letters to Animal Health Committee requesting governments act on implementing the Standards.
- Provided feedback to Australian Government on the impact of the live sheep trade moratorium and its effect on the stock feed industry.
- Worked with NSW Dept of Primary Industries to establish group permits for the importation of lupins into NSW from regions with anthracnose.



- Worked with the Australian Government and Australian Pork Ltd on African Swine Fever matters.
- Provided guidance to Skills Impact regarding training packages.
- Provided feedback on documents to the Codex Task Force On Antimicrobial Resistance.
- Assisted with the development of an Australian position regarding feedback on documents relating to Codex Committee on Contaminants in Foods.

Memberships

The SFMCA is represented on a number of working groups, committees, organisations that assist the Council in meeting certain outputs of our Strategic Plan 2017-22. These include:

Australian Agricultural Manufacturers Alliance

SFMCA partners with a range of agricultural manufacturing sectors (Australian Meat Industry Council, Australian Dairy Processor's Federation, Australian Oilseeds Federation, Australian Chicken Meat Federation, Cotton Ginners, Australian Sugar Milling Council) to enable common issues are developed and worked on. The alliance builds on or leverages the critical mass that's required by government to see an issue as being relevant. The alliance's major focus is on energy and the provision of cost effective, reliable base load energy requirements to our respective sectors.

Australian Oilseeds Federation (AOF)

The Council is a financial member of the AOF. As a result of this, your Executive Officer holds a seat on the AOF's Executive Committee.

Feed Grain Partnership

SFMCA is a partner working with key livestock industry sectors and their Research Development Corporations to coordinate research relating to feed grains and grain end use.

International Feed Industry Federation (IFIF)

We are a financial member of the IFIF and very active in the governance and projects led by the Federation. The Council's Chair (David Bray) is a member of the Executive Committee representing our (and those of the Feed Ingredients and Additives Association of Australia) needs on the international stage. We have chaired a small number of working groups and continue to provide strategic advice to organisations like the Food and Agriculture Organisation (FAO) and Codex Alimentarius that IFIF partners with.



National Working Party on Grain Protection

This working party is a committee of Grain Trade Australia (GTA) which looks at chemical use, contamination and storage options for grain in Australia. As this is an important issue for our membership SFMCA has positioned itself to be a conduit between the cutting edge of policy formulation and its membership.

SAFEMEAT

The Council was provided observer status on the SAFEMEAT Advisory Group during 2018-19. SAFEMEAT recognises the important part the

feed manufacturing industry plays in the food safety of the livestock industries.

TSE Freedom Assurance Program

SFMCA participates in this national program managed by Animal Health Australia which includes the ruminant feed ban controls. SFMCA has part funded this project since its inception in 2004.

Traceability Working Group

The Council provided guidance from an industry perspective on the development of key principles to be met by agricultural traceability programs. This work provided a cornerstone document for all agricultural sectors and governments in the development of traceability systems, which should be undertaken as a partnership between these two sectors.

Collaborations

Collaborations between and within organisations is a major component of working in and across sectors. It enables organisations to leverage off the other(s) and maximise returns whether these are financial or representational. This last financial year has seen a consolidation of this based on the work that has occurred over previous years. Special attention needs to be paid to the following organisations with which we work very closely:

- Australian Technical Millers Association (ATMA)
- Feed Ingredients and Additives Association of Australia (FIAAA)
- Grains Industry Association of Victoria (GIAV)
- Insect Protein Association of Australia (IPAA)

SFMCA works very closely with the ATMA and FIAAA on a number of fronts. We share office resources, we work together on various projects of common interest (e.g. antimicrobial resistance) and hold combined meetings where deemed beneficial to the party's membership. Most importantly, we partner on the Australasian Milling Conference. The GIAV and SFMCA continue to run an annual meeting and dinner with a small number of speakers on pertinent industry topics. This meeting consistently attracts over 120 attendees every year.

Australasian Milling Conference

Organisation for AMC 2020 is well advanced with the dates set for 17- 19 May 2020. AMC will again be conjointly held with PIX at the Gold Coast Convention and Exhibition Centre.

The 2020 conference theme is "Beyond 2020 - Feeding the Future". The speaker's program is taking shape with a number of speakers already agreeing to take part. The Gold Coast Convention and Exhibition Centre is a world-class venue and coupled with the exciting social program planned with the conference allows for relaxed discussion opportunities and a chance to catch up with friends and colleagues.

The first partners have made commitments to AMC and we look forward to other companies getting on board to support AMC as well as promoting their company. Bookings for trade exhibition stands are open and it is anticipated that we will again have over 280 stands taken up.



AMC is run by the three organisations: Australian Technical Millers' Association, the Feed Ingredients and Additives Association of Australia and Stock Feed Manufacturers' Council of Australia. Our AMC organising committee is led by David Bray as chairman with Neil Gannon chair of the program committee, Fiona Taylor chair of the social committee and Denis M'Gee the partners and exhibitors committee, together with other committee members.

AMC 2020 is shaping up to be a feature of our organisations activities for 2020 and we look forward to having a large number of our members attend.

Development Award

The next Development Award will be run in conjunction with AMC 2020. Applications for the Award will open in early 2020. The winners will take part in AMC 2020, followed by a tour of the Queensland stockfeed and livestock industries.



Membership


At the close of the financial year the number of Full/Provisional members was 105, this being a net gain of seven Provisional members through 2018/19. A number of these new members have joined SFMCA to access the FeedSafe accreditation program, leaving other organisations (and their integrity systems) to do so.

Associate membership has seen the loss of 15 members which have been replaced by 14 new associate members.

We welcomed Robert Parkes as a Life Member with this being recognised at a Victoria/Tasmania Branch meeting held in Melbourne in November 2018. Robert served our Victoria/Tasmania Branch and as national Chair for many years during the mid-2000s. Well done to Robert for his achievement and recognition by his peers.




The Council's ability to keep members is very good once the member has achieved FeedSafe accreditation and maintained the accreditation for at least 12 months.





FeedSafe Program


This past year has seen further growth in FeedSafe as nine additional sites completed accreditation. One site lost accreditation through the business sale and transfer to new owners.



As a result of the FeedSafe Review initiated by the Federal Council in 2017 the outcomes of the review were implemented on the 1 February 2019. The review was not to make sweeping changes, but to focus on perceived weaknesses and gaps in the existing program that could be addressed. The process included reviewing the FeedSafe Code of GMP, Audit Checklist and other guideline documents. The major outcome was the tightening of standards where a number of 'shoulds' were tightened to 'musts' and the introduction of non-conformance thresholds based on length of time spent in the program.

Since the implementation of the new thresholds a number of mills did not pass the audit and as a result required time to close out these non-conformances to ensure accreditation was maintained. In the period 1 February 2019 to 30 June 2019 ten accredited mills failed. Each mill was provided with two months to close out the non-conformances and have the auditor sign off and provide the paperwork back to the FeedSafe administrators. Every mill met this two month requirement. To put this into perspective 70 audits were undertaken in the same period.

The graph below shows the frequency of the non-conformances for the last financial year, effectively the number of times a question received a non-conformance.



Industry Training

The last twelve months has shown consolidation of the two training programs SFMCA developed and implemented.

FeedSafe Training Package

This program is for members and their staff. It is a free on-line course that can be accessed via the SFMCA website http://www.sfmca.com.au/feedsafe/feedsafe training/. These basic training units have been written for any employee to complete, even if they have no knowledge or experience in the stock feed industry. The training includes assessment questions with a printed certificate of completion. It is a great induction course that is being used by mills on an annual basis for their staff to reinforce the basic principles of FeedSafe.

Advanced Feed Milling Training Course

The SFMCA and UQ Skills (University of Queensland) joined forces to develop the Advanced Feed Milling Training Course which was launched in December 2015. During the last year we have seen a growing number of companies and their staff enrolling.

A total of 64 students enrolled in the full course or modules for 2018-19. There are 11 graduates of the course with all six modules having been completed. There are 17 member companies and five non-member companies utilising the course for the staff. There are also some internationally based companies using the course.

The training is flexible in allowing completion of either individual modules or the full course. Training provision is online using the University of Queensland Blackboard external student system. Employees complete the training at their own pace. They are required to complete training assessment tasks both by submitting for assessment as well as on-site assessment projects. Each company enrolling staff needs to have their own onsite supervisor.

NOTES TO THE FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED 30TH JUNE 2019

1 Statement of Accounting Policies

These financial statements are a special purpose financial report that have been prepared for distribution to the members to fulfil the committee's financial reporting requirements under the association's constitution and the Associations Incorporations Reform Act 2012 of Victoria.

The committee has determined that the association is not a reporting entity. The association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards. The financial report was prepared on a modified accrual basis of accounting, including the historical cost convention.

The following significant accounting policies used in the preparation of this report are consistent with previous years and are, in the opinion of the committee, appropriate to meet the needs of the members in accordance with its financial reporting requirements.

(a) Cash

Cash includes cash on hand, deposits held at call with banks and investments in term deposits with a term of three months or less and money market instruments, net of overdrafts.

(b) Revenue

All revenue is stated net of the amount of any goods and services tax. Revenue from fees are recognised from the date of invoicing which mostly occurs at the beginning of the the financial year for membership fees and at the time running events for other fees. Interest revenue is recognised when received from the bank.

(c) Taxation

The association is a self assessed not-for-profit educational and resource development organisation and hence specifically exempted from income tax on all its income.

(d) New Accounting Standards and Interpretations not yet mandatory or early adopted Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the association for the annual reporting period ended 30 June 2019. The incorporated association has not yet assessed the impact of these new or amended Accounting Standards and Interpretations.

(e) Events after the reporting period

No matter or circumstance has arisen since 30 June 2019 that has significantly affected, or may significantly affect the incorporated association's operations, the results of those operations, or the incorporated association's state of affairs in future financial years

(f) General Information

The financial statements cover Stock Feed Manufacturers' Council of Australia Inc as an individual entity. The financial statements are presented in Australian dollars.
